Our History

ICLA was first established in 1984 to aid a group of boarding house residents in Bondi who were facing eviction.

"Rotorua" was a privately operated boarding house for more than ten years, providing accommodation for 29 people with psychiatric disabilities. When the property was put up for sale group of community health workers, students, family members and others from the community worked to form ICLA and were able to negotiate with the NSW Department of Housing to secure appropriate alternative accommodation.
